



## Fiberglass Step 10 Year Limited Warranty

### 1. Style Crest, Inc. hereby warrants:

- (a) That Style Crest® fiberglass steps are manufactured of specifically selected materials and are under continuous quality control from start to finish.
- (b) That the unique process used to join exterior grade plywood and the fiberglass finish are the most advanced available and are under continuous study for improved methods.

### 2. Style Crest, Inc. warrants to the owner of a genuine Style Crest® fiberglass step installed within the limits of continental United State's, that any structural failure resulting under normal use during the limited warrantee period will be resolved as follows:

- (a) If after inspection by Style Crest® or their authorized agent it is determined that a Style Crest step has become defective under normal usage, Style Crest agrees, at their option, to refinish or replace the defective unit based on our replacement schedule. (See 3-IV)
- (b) The limited warranty is for material only and does not include labor nor does it apply, nor does Style Crest® assume any obligation for defects resulting from installation, acts of God or vandalism.
- (c) Any claim under this guarantee must be made in writing to Style Crest®. It is stipulated that Style Crest shall have no obligation unless they shall be granted reasonable opportunity to inspect the defect.
- (d) This limited warranty is null and void if the step has not received reasonable maintenance or has been abused.
- (e) This limited warranty is valid only if the Registration Certificate is sent by the original purchaser from an authorized Style Crest® dealer to:

within (30) days of installation.

### 3. The following procedure will be followed upon notification of any defective units:

- (a) Claim form will be sent and must be filled out completely.
- (b) Two pictures must be taken of the defective step. One of the defective area and one of the full unit.
- (c) After receipt of the above information and verification is made by Style Crest® notification will be made to the customer as to the following:
  - I. Remove the rails and return the step (boxed if possible), FREIGHT PREPAID to:  
STYLE CREST, INC. 600 HAGERTY DR.  
FREMONT, OHIO 43420.
  - II. Upon receipt of the step Style Crest® will replace or repair same and return the unit to you FREIGHT COLLECT.
  - III. A charge for the step will be made according to our replacement schedule.
